2016 Statistics Data

OHS Supervisions: - 6,815 (majority-proactive)

OHS Measures: 4,748 (written orders: 62%; fines: 15%; warnings: 23%)

OHS Violations: 21,521 total;

- Risk Assessment: 19.5%
- Training of workers: 11.6%
- Working conditions on constructions sides: 9.2%
- Working Equipment: 8.9%
- Medical Examination: 7.7%
- PPE (Personal Protective Equipment): 7.4%

- Occupational Accidents (ESAW): apx. 9,100 (fatalities:15,
serious: apx. 450)

OHS at work and Posted Workers in SLO:

- Equal to slovene workers
- No additional demands regarding specific OHS documentation (Risk Assessment, Training documentation, medical certificate, ...)
- LIRS accept „foreign“ documentation as adequate if reflect /resume situation
- Documentation language: original + certified translation (if necessary) for EU countries
